Artist Rules

1. The Holiday Bazaar is a juried show. All new applicants must submit 3+ photos of their work for committee review. Returning artists with new or different products must submit photos of those products. Upon acceptance into the show, please submit your booth fee.
Application deadline is November 11.
2. All work must be original and handcrafted, created and exhibited by the approved artist themselves. Kits, imports, and mass-produced items will not be allowed.
3. Artists must be present for the entirety of the show.
4. Displays must be professional and aesthetically pleasing.
5. Artists are responsible for tables, chairs, and all display pieces. All booths will be under large, event-style tents provided by the show.
6. Artists who break down booths and leave prior to the end of the show will not be allowed to return to the following show, unless in case of emergency.
7. Artists are responsible for collecting and paying sales tax (6%).
8. Artists will be considered a "no-show" if a space is not occupied by 9:00 a.m. on Friday, November 27.
9. Early setup is 9 a.m. – 3 p.m. on Wednesday, Nov. 25. Early setup is for display pieces only—**no product**.
10. Vehicles must be removed from show area to the parking field by 8:45 a.m. to allow for customer parking.
11. Setup and breakdown times will be strictly enforced.

Admission

Booths and booth placement are subject to availability. Booth placement is distributed on a first-come, first-served basis. If you have a booth preference, please complete the "Special Requests" section in the application.

Deadline

All applications are due by November 11.

Jury Process

All new applicants and photos are subject to review by the Holiday Bazaar Jury Committee. All artists are to provide a list of items for approval to exhibit and sell at the show. The applicant will be notified after the committee reviews the application and decides on admission.

Payment

Cash or Checks only. Make checks payable to **Russell Lands On Lake Martin**. Payment should not be submitted until after artist has been notified of acceptance.

COVID-19

To maintain adherence to social distancing requirements, vendor space is limited. Booth layouts have been altered to maximize open space. Masks & hand sanitizer will be provided. Masks are required to enter the show. Event and booth layout are subject to change.

Wait List

Once tent capacity is reached, applicants will be placed on a wait list given the applicant passes the jury process.

Taxes

Artists are responsible for collecting and paying sales tax (6%).

Booth Information

Single booth: 10' x 10'
Double booth: 10' x 25'

Reproductions

Reproductions of a participating artist's original work are permitted, but they must not exceed 25% of the total products offered for sale by any artist during the show.

Weather

The show will be held rain or shine. All booths are under large, event-style tents.

Security

Russell Crossroads security is on-site every night, 10:00 p.m. – 6:00 a.m. **Russell Lands is not responsible for anything left on the Town Green overnight.**
