## Artist Rules

1. **Arti Gras is a juried show.** All new applicants must submit 3+ photos of their work for committee review. Returning artists with new or different products must submit photos of those products. Upon acceptance into the show, please submit your booth fee.  
**Application deadline is June 21.**
2. All work must be original and handcrafted, created and exhibited by the approved artist themselves. Kits, imports, and mass-produced items will not be allowed.
3. Artists must be present both days of the show.
4. Displays must be professional and aesthetically pleasing.
5. Artists are responsible for tables, chairs, and all display pieces. All booths will be under two large, event-style tents provided by the show.
6. Artists who break down booths and leave prior to the end of the show will not be allowed to return to the following show, unless in case of emergency.
7. Artists are responsible for collecting and paying sales tax (6%).
8. Artists will be considered a "no-show" if a space is not occupied by 12:00 p.m. on Friday, July 6.
9. Early setup time is 9 a.m.–3 p.m. on Thursday, July 5. Early setup is for display pieces only—no product.
10. Vehicles must be removed from show area to the parking field by 12:00 p.m. on Friday to allow for customer parking.
11. Setup and breakdown times will be strictly enforced.

### Admission

Booths and booth placement are subject to availability. Booth placement is distributed on a first-come, first-served basis. If you have a booth preference, please complete the "Special Requests" section in the application.

### Deadline

All applications are due by June 21.

### Jury Process

All new applicants and photos are subject to review by the Arti Gras Jury Committee. Returning artists with new or different products must submit photos of those products. The applicant will be notified after the committee reviews the application and decides on admission.

### Payment

Cash or Checks only. Make checks payable to Russell Lands On Lake Martin. Payment should not be submitted until after artists have been notified of acceptance.

### Refunds

All cancellations must be submitted to Tyler Mitchell, 256.212.1443, tmitchell@russellands.com. Full refunds will be given until June 1. No refunds will be given after June 2.

### Wait List

Once tent capacity is reached, applicants will be placed on a wait list given the applicant passes the jury process.

### Taxes

Artists are responsible for collecting and paying sales tax (6%).

### Booth Information

Single booths are 10' x 10'.

Double booths are 10' x 20'.

### Reproductions

Reproductions of a participating artist's original work are permitted, but they must not exceed 25% of the total products offered for sale by any artist during the show.

### Weather

The show will be held rain or shine. All booths are under large, event-style tents.

### Security

The Town Green will be monitored outside of show hours Thursday–Saturday.

### Advertising

Arti Gras will be promoted utilizing print, digital, radio, and social media advertising.
